ABVE 2005 SpringCONFERENCE March 18 - 20, 2005



The upcoming conference in New Orleans, LA in the Spring of 2005 will be the first of two conferences held in 2005. The New Orleans conference will highlight the areas: a) Validity of the physical capacities evaluation, b) information concerning psychiatric and psychological disabilities, c) there will be a break-out session where members can learn about: (1) the operation of ABVE through ABVE Headquarters, (2) how to respond to an opposing expert's report, (3) how to prepare and present cross examination testimony and, (4) how to submit an article for publication in the ABVE Journal. Additional workshops are planned concerning impairment ratings and how they relate to functional work restrictions.

Two pre-workshop programs have been developed. Dr. Larry Sinsabaugh will be presenting a program entitled Vocational Experts Testimony imputing income and outcome over troublesome issues in spousal support cases. In addition, Dr. Growick and Dr. May will present a pre-workshop program on Life Care Planning and Vocational Expert Testimony. Dr. Tim Fields is the keynote speaker for this conference and will be presenting a program on the admissibility of testimony, involving Vocational Experts. The ABVE Board is actively trying to develop locations that will be both attractive to perspective attendees, as well as moving the conferences around, across the country, which will make them at some point accessible to everyone.

Remember, attending the conference helps obtain your necessary Continuing Education Credits.

President's Message

On November 19, 2004, I met with members of your Executive Committee and Test Committee in Philadelphia to review our present Entrance Examination and Knowledge Enhancement curriculum. I was accompanied by Vice President Donald Jennings, Test Committee Chair William McCroskey, Credentialing Chair also Test committee member Scott Streater, and new Test committee member Philip Spergel. Recommendations after a review of the examination suggest some immediate changes and others to be made subsequent to further data collection. In addition, it was recommended that the Knowledge Enhancement

curriculum be expanded to provide more information concerning test questions. Our earlier test was a very highly valid instrument and the added test questions to cover the variety of work that people perform in our field did not affect its validity. In fact, our present test remains a very valid instrument.

Dr. McCroskey has written a monograph supporting our test validity and it will be published as a monograph by ABVE. Dr. McCroskey will also be developing a study curriculum to be distributed to test takers prior to their examination to help them become familiar with the areas in which they will be tested. In fact, we are trying to have this information in disc form prior to our New Orleans meeting in the spring.

Moreover, seeing that Dr. McCroskey will be responsible for the Knowledge Enhancement program, I am now designating him chairman of the Test and Knowledge Enhancement Committee of the Board of ABVE. Philip Spergel has also agreed to assist him and has become a new member of the committee. Let me add that Dr. McCroskey, in the committee's opinion, after reviewing all his test data, has done an excellent job validating our test. Our present test is a terrific instrument and Dr. McCroskey deserves a great deal of credit for its statistical design. I would also like to thank the committee members and all ABVE members that contributed test questions and assisted Dr. McCroskey in his statistical analysis.

Journal Activities

The next issue of the Journal of Forensic Vocational Analysis (JFVA) is currently in print. Gale Gibson, ABVE member and founder of VERTEK Inc, served as guest editor for this Special Issue. The focus of the issue is on the use of Functional Capacity Evaluations (FCEs), specifically as they relate to forensic vocational assessment.

The December, 2004 issue contains contributions from Gale Gibson, as well as Dr. Phyllis King of the University of Wisconsin-Milwaukee ("Analysis of the Reliability and Validity supporting Functional Capacity Evaluation"), Dr. Randall McDaniel, Joshua Tilton, and Anthony Philadelphia, all from Auburn University ("Use of the FCE in the Vocational Expert Practice"), Dr. Kenneth Harwood from the American Physical Therapy Association ("A Review of Clinical Practice Guidelines for FCEs"), Deborah Lechner ("A well-designed FCE: Application in forensic vocational analysis"), Mark Dakos ("The Application of FCEs in the provision of Vocational Expert Services"), and Attorney Bobbi Dominick ("Daubert and Decisions: Will FCEs Hold up in Court?"). The editors would like to thank Mr. Gibson for his work as special editor, as well as all of the contributors to the JFVA.

The JFVA Editorial committee is also in the process of proposing to the ABVE Board of Directors a Journal-specific CEU initiative, a proposal which will enable ABVE members to receive continuing education credits through reading and responding to a Journal article. Also being considered is web-based accessibility of manuscripts submitted for publication to the Journal, allowing for easier access and faster review by our Editorial committee. And finally, a proposal to increase distribution options of the Journal to non-members of ABVE, i.e., greater marketing of our Journal.

The December 2004 issue should arrive to members in January. The editors are currently reviewing manuscripts for the Spring 2005 issue, which will be a general issue, to be released in June. NEW Q & A Corner

Question: What is the process for a member if they feel that another ABVE

member has violated the ABVE Code of Ethics?

Answer: This member's question has been answered by Dr. Phil Sperling,

Chairman ABVE Ethics Committee.

THE PROCEDURE FOR ADJUDICATING ETHICAL COMPLAINTS A.B.V.E.

1. The Ethical Complaint

- A. When an A.B.V.E. member believes that another member of the organization has violated one or more of the Ethics Codes, that member should contact the suspected Code violator and inform him or her of the Code or Codes believed to be violated. Hopefully, the matter can be resolved between the involved parties without a formal complaint being filed with the Ethics Committee.
- B. If the matter cannot be resolved between the parties, the member who suspects there has been an Ethical Code or Codes violation should then file a written formal complaint (with two copies) to the Chair of the Ethics Committee.
 - 1. The letter should include the following:
 - a. The name of the individual who suspects a violation has occurred as well as the name of the suspected violator.
 - b. The Code or Codes that may have been violated.
 - c. A summary of the discussion held between the member filing the complaint and the member suspected of Code(s) violation.
 - d. The member filing the complaint should sign the letter and forward a copy of the communication to the individual suspected of the violation.
 - 2. If the suspected member believes that he or she has been wrongly accused of the A.B.V.E. Code violation, then he or she should forward a written letter to the Chair of the Ethics Committee explaining his or her position and why he or she feels there had not been violation of the Code.
 - a. That letter should also be signed by the individual with a copy sent to the member who has filed the complaint.
 - b. It is important that all correspondence be written and not sent electronically (neither e-mail nor fax) so that confidentiality can be maintained.
